- Preferred candidates will have dual secondary certifications.

- Rock-solid commitment to the mission and ideas of New Tech High.
- Excellent collaborative skills.
- Excellent communication skills (written and verbal).

Selected candidates must have the ability to:

2. Design and deliver orientation and training to students prior to school opening.
3. Work as an interdisciplinary team across content areas to ensure curricula is aligned to meet state and local requirements.
4. Effectively instruct students in assigned areas (s) as prescribed by New Tech guidelines and requirements.
