#### Call to Order

Mr. Bemiss called the meeting to order at 7:30 p.m.

#### Amend and/or Adopt Agenda

Mr. Hansford made a motion to adopt the agenda as presented. Mr. Bramer seconded; the vote was 4-0.

#### Acknowledgements and Recognition

Dr. Knott honored the September Students of the Month. Abbey Muellner from Clarksville Elementary School, Hannah Morris from Clarksville High School and Hayden Parks from Renaissance Academy were all present. April Jackson from Clarksville Middle School was not in attendance.

#### Adoption of 2017 Budget

Dr. Knott presented the 2017 budget. She noted that the assessed valuation has decreased six of the past seven years and at this time it is not known what the AV is for 2017. CCSC is advertising a \$250,000,000 AV. Dr. Knott reported that the 2016 Circuit Breaker impact could be \$1 million and possibly as high as \$1.7

million in lost revenue. She noted that the official ADM is 1394.9 in September 2016, compared to 1385.3 in September 2015. She also reported that the 100% of the Retirement pension debt would have to be neutralized by law. She said this will be done by using one or all of the levies in Bus Replacement, Transportation and CPF. Dr. Knott noted that Legislation remains favorably skewed to corporations with low populations of disadvantaged groups. The 2017 advertised totals: All budget \$17,863,759, all levies and rates \$7,111.129 and a total tax rate of 2.8444.

Upon Dr. Knott's recommendation, Mr. Hansford made a motion to adopt the 2017 Budget as presented. Mr. Bramer seconded; the vote was 4-0.

### Reports of School and Organization Representatives

Superintendent's Reports: Dr. Knott congratulated Ms. Nikki Bullington, CMS Principal, for her nomination as a "Maker of Change" in Education.

Dr. Knott confirmed with Board Members that all future meetings would be held at Renaissance Academy.

Dr. Knott discussed a change that would decrease the Corporation's cost of PERF for people hired after January 1, 2017. Mr. Bramer and Mr. Bemiss said they didn't think changes should be made.

Dr. Knott noted a 37.85% increase quoted by Anthem for health insurance. She said that currently individuals choosing the high deductible plan are paying for those who have the low deductible plan and the Corporation should consider moving with just one plan in the future. Dr. Knott informed the board that the increase is due to nearly \$400,000 more in claims this year. This increase has nothing to do with the agent as suggested by Mr. Bramer.

Dr. Knott also talked about CCSC's participation in ClarkFEST 2016 and the upcoming Trick or Treat at CMS and Firefighter "Thank You" Luncheon.

#### Comments

C.E.A. Communications: Ms. Janet Wagner, C.E.A. President said a recent article in the Louisville Courier Journal did not paint a flattering picture of CCSC. She noted that of the 88 teachers in the Corporation, 55 have been in the district for five years or less. She added that she doesn't believe teachers leave due to conflicts with Administration as was noted in the article. Ms. Wagner said the biggest reasons teachers leave CCSC are the rigor of TAP and salary. She said it's a great place to work but that CCSC needs to find out what can be done to attract good teachers and retain the current ones.

Board Members: Ms. Hauber said the loss of teachers is the reason she wanted to be on the board, to help find a fix. Mr. Bramer said he got to tour the new locker rooms at CMS and was impressed. Mr. Bemiss said CCSC has special staff and kids and is lucky to have the people it does. He also urged people to vote.

#### Consent Agenda

Upon Dr. Knott's recommendation, Ms. Hauber made a motion to approve the Consent Agenda, as presented. Mr. Hansford seconded; the vote was 4-0.

### **Debt Service Obligation for New Bonds**

Dr. Knott introduced Mr. Mike Therber from Therber and Brock to discuss the Debt Service Obligation and options for new bonds. He said Option One would be a lower rate impact for the first four years with an increase after current bonds are paid off. Option Two is a more standard payment amount for the term of the bonds.

Dr. Knott recommended option one. Mr. Hansford made a motion to accept the recommendation. Mr. Bemiss seconded; the vote was 4-0.

Dr. Knott reminded the Board about the special meeting Thursday and noted that CCSC would be ready to sell bonds after that meeting.

#### Personnel

Upon Dr. Knott's recommendation, Mr. Bramer made a motion to approve the Personnel Report, as presented. Ms. Hauber seconded; the vote was 4-0.
