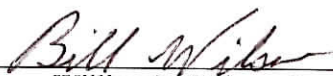

**Fund Raising Request:**

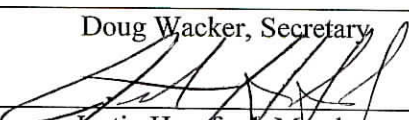

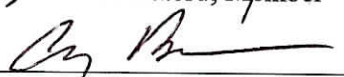

Dr. Knott updated the ADM numbers showing 1385.3 students.

Dr. Knott discussed the schedule for bids on bonds. The schedule calls for the board to award a contract November, 10, 2015.

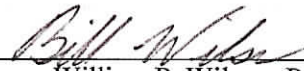

**Non-resident student transfers:**

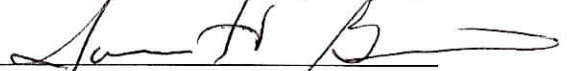
Dr. Knott discussed 4 non-resident student transfer requests for the second semester that need to be approved.

With no further business to discuss, Mr. Wilson adjourned the meeting at 8:07 p.m.

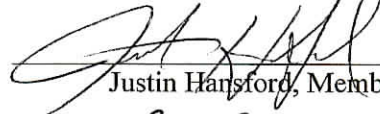
