Call to Order

Mr. Wilson called the Planning Session to order at 7:36 p.m.

Amend and/or Adopt Agenda

Education Update

Superintendent Bennett reported on the corporation letter grades. Clarksville Elementary School is an A school this year and Clarksville Middle School, Clarksville High School and Renaissance Academy are a B. She noted the corporation moved from a C to a B. Superintendent Bennett presented ISTEP scores to the Board and noted CCSC was above state average in five categories this year compared to last year. She also noted an 89% pass rate for this year's IREAD. Superintendent Bennett noted that the Clarksville Middle School band and choir concert was taking place at the same as the meeting and that the High School had their concert on Thursday. She thanked Ms. Goldman and Ms. Rupprecht for coordinating the Build a Bed Project with the Metro United Way. She noted that beds were provided for seven Clarksville students. Superintendent Bennett said shopping for Clarksville Cares was set for Sunday.

Superintendent's Reports

Superintendent Bennett said she would be bringing recommendations next week to the Board for the teacher appreciation grant, classified retention bonus and administrator performance based stipends. Superintendent Bennett shared the most recent transfer report on students. She also reported that CCSC now has AED's (defibrillators), rescue kits and stop the bleed kits in each building. Some of these were donated from Clark Memorial and some were purchased by the corporation. Superintendent Bennett said cafeteria tables have been ordered for the high school.

Comments

C. E. A. Communications: Ms. Janet Wagner, C.E.A. President, said the ELA and math teachers have been working very hard. She asked that the schedule be looked at to not have band and choir concerts on the same night as School Board meetings. She also noted that the proposed school calendar had been reviewed several times by the C.E.A.

Comments from Board Members: Ms. Wilson said the letter grades are showing the hard work that's being done. Ms. Hauber welcomed Erin Walden. Mr. Wilson mentioned another district that is now offering a free college education to graduates. He pointed out that Clarksville students are already getting free college credits.

2019/2020 CCSC School Calendar

Superintendent Bennett presented the proposed 2019/2020 school calendar. She said the calendar is very similar to the current school year but noted a few changes. Those changes include the addition of two early release days for professional development, the moving of parent teacher conferences to November, taking off MLK and President's Day and using Oaks Day and Election Day in May as make up days.

Superintendent Bennett noted there are no additional personnel items at this time.

Revision to Statement of Benefits for Maintenance Employees

Superintendent Bennett discussed a Revision to the Statement of Benefits for Maintenance Employees. She said she wants to add an additional level of pay based on credentials. She noted that it doesn't add any additional salary, but rather incentivizes the lead maintenance worker to acquire certifications in order to earn the highest pay rate.
