She noted currently that the only area where that gap is over ten percent is Special Education. She noted that the district is still waiting on ISTEP scores. Superintendent Bennett told the Board that the Corporation is working on incorporating the Governor's Work Ethic Certification Program.

Mr. Wilson asked the Board to move up part of agenda item #12. Superintendent Bennett introduced Ms. Barbara Cline, a 1972 Clarksville Alum. Ms. Cline is employed by Ward Engineering and the company donated a new grill that will be located at the Clarksville High School football field. Ms. Cline said they are happy to support the school and sports.

Superintendent Bennett said the district has been discussing the upcoming solar eclipse and how to incorporate it in the classroom.

**Superintendent's Reports**

Superintendent Bennett noted there are currently 1345 students enrolled at Clarksville Community Schools. She reported that the back to school walk and back to school opening went well. Board members agreed the media coverage was great. Superintendent Bennett also noted that she and Dr. Allred had a meeting with the Clarksville Town Manager and they hoped to solidify a project with Renaissance Academy students.

C.E.A. Communications: Mr. Alan Kashtai, C.E.A. Vice President, said it has been a great start to the school year. He thanked Ms. Nikki Bullington, CMS Principal, for the idea of having "houses" for students this year.

Board Members: Ms. Lynn Wilson said the IREAD-3 scores looked really good. She thanked Barbara Cline and said football is coming up. Mr. Jim Payne reminded the Board about the touch-a-truck event on Friday. He also noted that Kroger is once again hosting another donation for back to school kits this year and said they have a big collection so far. Ms. Hauber thanked everyone for a good first day. She said she was proud to be here. Mr. Justin Hansford said the vibe has been great.

**Facilities Update**

Superintendent Bennett introduced Mr. Rick Jackson, Director of Facilities and Operations. Mr. Jackson updated the Board on the renovation work at Clarksville Middle School, Clarksville High School and Renaissance Academy. He noted that the majority of the projects are completed. He said all were on or under budget.

**Personnel**

Superintendent Bennett discussed personnel. She noted that the Corporation has hired all remaining teachers for the 2017-2018 school year.


**Adjourn**
