Clarksville Middle School and Clarksville High School and increases at Clarksville Elementary School and Renaissance Academy.

Mr. Wilson said he was upset with the enrollment at Renaissance Academy. He said some serious discussions need to be had on that issue. Dr. Knott noted that many of our out of district students are at Renaissance Academy. Mr. Bemiss said that the district needs to get more students.

Dr. Knott thanked everyone for their work on the butterfly launch with Clarksville Elementary students and the Clarksville Police Department thank you luncheon at Renaissance Academy. She also talked about the Grade Four Leadership Academy and noted that Clarksville Middle School was leading the district in attendance at 97.5%. She also discussed a College Prep Night hosted by One Vision Credit Union.

#### Superintendent's Reports

Dr. Knott reviewed the bond planning calendar with the Board. She noted that the first meeting would take place September 13, 2016 when the Building Corporation would organize. She said November will be the anticipated sale of bonds. She also noted that the GO bond will help pay for improvements needed at buildings for special education students next year.
