Call to Order/Pledge of Allegiance

Mr. Wilson called the Regular Meeting to order at 7:00 p.m. and asked those in attendance to recite the Pledge of Allegiance.

Amend and/or Adopt Agenda

Ms. Wilson made a motion to adopt the agenda, as presented. Mr. Hansford seconded; the vote was unanimous.

Acknowledgements and Recognition

Superintendent Bennett honored the August Students of the Month. Audrey Hillerich from Clarksville Elementary School, Kirsten Cummings from Clarksville High School and Alyssa Leezer from Renaissance Academy were all in attendance. Mikie Pirtle from Clarksville Middle School was unable to attend. Superintendent Bennett introduced Ms. Nikki Bullington, CMS Principal. Ms. Bullington honored Ms. Kelly Glover, CMS Treasurer/Secretary, with the Above and Beyond Award.

Reports of School and Organization Representatives

Superintendent Reports: Superintendent Bennett updated the Board on the small claims collections for textbook rental fees. She noted that the debt balance for the 2018-2019 school year is significantly lower

than for the 2017-2018 school year. She said the next step in collecting unpaid fees will be to garnish wages. Superintendent Bennett told the Board that CCSC has partnered with Greater Clark County Schools in hopes of receiving the McKinney Vento Grant. She also said CCSC was changing vendors for the mandatory drug testing of bus drivers. She said the change will equate to a cost savings. Superintendent Bennett gave the Board an update on the ILEARN scores saying they show that CCSC is above state average in most categories across grade levels. She also noted that count day is coming up and currently there are 1353 students enrolled. Superintendent Bennett said the Administrative team is looking at adding additional late start or early release days this school year to provide professional development opportunities for staff, specifically mindfulness training. She also reported that Mr. Colin Bell, PE Teacher at Clarksville High School, is hoping to start a new club offering high school and middle school students the opportunity to play and learn more about soccer. She said the club will also give CCSC an opportunity to evaluate the interest level of students in the sport. Superintendent Bennett also updated the Board on the Duke Energy Powershare program, noting that CCSC will get \$20,000 in rebates.

Comments

C. E. A. Communications: Ms. Brandi Dreher, C.E.A. Vice President, congratulated all students for their hard work and dedication on ILEARN. She discussed enrollment numbers, TRF money and cost savings on subs and said she hoped the Board would invest in teachers this year.

Comments from Board Members: Ms. Wilson congratulated Ms. Cummings for her daughter being a student of the month for Clarksville High School. Ms. Wilson also urged everyone to attend the football game against Providence on Friday.

Superintendent Bennett thanked the committee for taking their time in making sure the process was fair, transparent, and followed Board policy. She also thanked the Board for their thoughtfulness on the matter. She noted that the signage should be similar to what is already in place for baseball and softball. Mr. Wilson noted that the naming should be completed as soon as possible and both Mr. Newcom and Mr. Hawkins should be invited.
