Call to Order

Education Update

Superintendent Bennett told the Board that ILEARN scores were embargoed for release but noted that Clarksville's pass rates looked promising. She said the state was considering making this a hold harmless year since the ILEARN test is new.

Superintendent's Reports

Superintendent Bennett gave the Board an update on enrollment. She said there are currently 1354 students, which is up from last year's count day. She also noted that the out of district rate was at 28%.

Superintendent Bennett told the Board that Renaissance Academy will host College Go Sunday in November. The event allows students and parents from Southern Indiana to get support on filling out paperwork. Superintendent Bennett told the Board that the filming was complete for the WHAS Great Day Live segment that will air later in September. She said students from each building were interviewed. She also reported that the new website was in the last phase of completion. Superintendent Bennett also showed the Board a medal that was used for the Hokum Karem Cross Country Relays at West Clark Community Schools. She said the medals were made by students at Renaissance Academy.

Comments

C. E. A. Communications: Ms. Sally Wade, C.E.A. Representative, thanked the Board for bringing forth the TRF resolution, saying she hoped it would help teachers.

Citizens Comments: Seven residents signed up to speak. Mr. Nick Wilson, a Clarksville graduate, read from his recommendation to name the Football field after former coach Guy Newcom and the fieldhouse after former coach Dennis Hawkins. He talked about the records for both and said they deserve the honor. Mr. Chris Broughton, a 1973 graduate, said that he played football for both coaches. He said it was a wonderful idea to name the facilities after the men. Mr. Tim Buckman, a 1974 graduate, said he was proud to play for Clarksville and thinks naming the facilities would be a great story to tell. Ms. Angie Vittitow, a 1971 graduate, read from an old Clarksville Crier article about Mr. Newcom. She said he was loved and respected and noted that she was in support of the facility naming. Mr. Jack McIntire, a 1974 graduate, said Mr. Newcom touched so many lives and that it was time to honor him and thank him for giving to the community. Ms. Shirley Makowsky said she knew coach Newcom and his wife well. As a cheerleader she said he always respected her and said the naming proposal should be considered. Ms. Kelly Banks, a 1979 graduate, said she feels that Mr. Newcom should be honored while he is still alive.

Recommendation for Facility Naming

Superintendent Bennett told the Board the written request for the facility naming was received on August 20th. She noted that she had met with Ms. Goldman and Mr. Carmichael and assembled a committee per Board Policy. She noted that once the committee met and submitted their recommendation that she would bring it back to the Board. She reminded the Board they have the ultimate authority to accept, reject or modify any recommendation that is brought forth.
