- 1. CHS-800 Dr. Dot Lewis Drive; Clarksville, IN.** Door #11 Entrance (glass doors at Gym Entrance between CES & CHS). Enter the single door marked “ENTER” and exit through the single door marked “EXIT.”
- 2. Renaissance Academy-806 Eastern Blvd; Clarksville, IN.** Rear Entrance/Canopy (off of Little League Blvd). Enter the single door marked “ENTER” and exit through the single door marked “EXIT.”
