Dear Parent or Guardian:

We are pleased to inform you that <u>Clarksville Community School Corporation</u> will be continuing our participation in the Community Eligibility Provision (CEP) for the 2020-2021 school year.

What does this mean for you and your children attending the school(s) identified above? THIS MEANS GREAT NEWS for ALL ENROLLED STUDENTS OF:

<u>Clarksville Elementary, Clarksville Middle, Clarksville HS and Renaissance Academy</u> are eligible to receive a healthy breakfast and lunch at school at <u>no charge</u> to your household each day of the 2020-2021 year. No further action is required of you. Your child(ren) will be able to participate in these <u>meals-only</u> programs without having to pay a fee or submit a *Meal application. Extras or A la carte items will still require funds for purchasing as per our Meal Account Policy.

*Curricular Materials (formerly Textbooks) Assistance <u>is not</u> included in this program so applications will still need to be filled out for those families that feel they qualify for this assistance <u>unless</u> you have otherwise been notified by CCSC Food Services Dept. There are 3 ways to apply:

1. Online via Infinite Campus and submit the application following the prompts.

2. Request a paper application from your student's school office. Please fill out the form and return it to your student's school office for processing.

3. Visit our website <u>www.ccsc.k12.in.us</u> under the Menu icon for instructions as well as a printable curricular materials application along with our Revised Meal Account Policy & Parent Acknowledgement Form. ****Please be advised that if you do not apply & become approved for this benefit you will be held financially responsible for all curricular materials fees for the school year and will be billed accordingly.**
