Call to Order

Mr. Hansford called the Planning Session to order at 7:10 p.m.

Amend and/or Adopt Agenda

Ms. Wilson made a motion to adopt the agenda, as presented. Ms. Cummings seconded; the vote was unanimous.

Education Update

Superintendent Bennett said there have been multiple meetings with the virtual school provider to develop Indiana Gateway Digital Academy. She said many details are still being finalized including K-12 having office space at Clarksville Middle School. She said Indiana Gateway Digital Academy will follow the same calendar as CCSC and will be a K-11 for year one. Superintendent Bennett said interviews would be conducted later in the week for the new Director of Renaissance Academy. She hoped to have a candidate the following week. Superintendent Bennett noted that registration at CCSC was currently at 875 students for the upcoming school year, a higher number than the previous year during the same period of time. She said the administration is having conversations around possible back to school events. Superintendent Bennett updated the board that existing cleaning solutions for student devices are not safe to use on the computers. As a result, she noted that Mr. Crane is purchasing an insurance package that includes a protective case for every student to have a device of their own.

Superintendent's Reports

Superintendent Bennett updated the board on various summer facilities projects including the CMS entry and office remodel, football field lighting and tree removal. She also said work would soon begin on the Clarksville High and Clarksville Elementary School roof projects. Superintendent Bennett showed the board a copy of the postcard being mailed out to 4800 homes around Clarksville. She said they are targeted in the Parkwood and Gutford Road areas. She noted that welcome back boxes would be handed out again this year and a back to school video would be filmed focusing on the re-entry plan and other pertinent information. She also asked the board to save the date for August 4th for the annual back to school kickoff event. She said it would be outdoors in the afternoon.

Comments

C. E. A. Communications: Ms. Sally Wade, C.E.A. Secretary, noted that teachers are anxious to ready their rooms due to the new guidelines. She said everyone wants to be back with their kids in the classroom, as safely as possible. She also noted that she appreciated any plan that is putting people first and is glad as many staff members as possible are being retained during these uncertain times.

Comments from Board Members: Ms. Wilson said she is proud of CCSC staff and what has been done. Mr. Hansford said the Board is doing what it can to keep staff and students safe.

Face Mask Policy

Superintendent Bennett discussed the recommended face mask policy written by the Indiana School Boards Association. She noted the policy was brought forth due to a recommendation from the Indiana Department of Education. She said the policy basically says CCSC will not charge students for the masks provided by the DOE.

Revisions to Curricular Material Fees and Consumables

Superintendent Bennett discussed revisions to the 2020/2021 Curricular Material Fees and Consumables at CES and CMS.

RDC Agreement

Superintendent Bennett discussed the Agreement for Programs with the Clarksville Redevelopment Commission. The Agreement says the RDC will pay CCSC up to \$240,000 from TIF annually for three years towards Clarksville Community Schools' 21st Century Technology Readiness Plan.

Superintendent Bennett discussed donations.




With no further business to discuss, Mr. Hansford adjourned the meeting at 7:35 p.m.




