**Call to Order**

Mr. Hansford called the Planning Session to order at 7:20 p.m.

**Amend and/or Adopt Agenda**

Ms. Wilson made a motion to adopt the agenda, as presented. Ms. Cummings seconded; the vote was unanimous.

**Education Update**

Superintendent Bennett said school had started under a hybrid schedule and that CCSC had received a lot of positive feedback from building leaders and staff on the ability to socially distance. She said monitoring COVID-19 in the area would continue and a decision would be made next week about returning in person August 24. She also said there was a positive case reported to us from a parent of a high school student who attended school in person the week before. She noted CCSC followed the process of contact tracing and communication with the health department. Superintendent Bennett said the first few days of remote learning had gone incredibly well with a much higher level of student engagement and academic rigor than in the spring. She also said meal delivery was continuing for students during remote learning. Superintendent Bennett said she would begin providing enrollment updates next week for the brick and mortar. She then introduced Dr. Brian Allred to give an update on enrollment for Indiana Gateway Digital Academy. Dr. Allred said he's been in daily contact with K12 and so far they have approved enrollments for almost 1000 students across the state, at least one student in every county in Indiana. He said 103 students were from CCSC. He said the target enrollment is 2000 students.

**Superintendent's Reports**

Superintendent Bennett told the Board that the timeline is in place for this year's budget. She said she, Dr. Kidd and Dianne had been working on it and were making good progress. She said a more definitive enrollment number for brick and mortar as well as virtual would have an impact. Superintendent Bennett said the date for the required pre-bargaining public hearing would be August 18 and would be conducted by the Corporation and C.E.A. Superintendent Bennett said she planned to recognize some outstanding alumni and community partners at a future meeting.

**Comments**

C. E. A. Communications: Ms. Christina Schotter, C.E.A. President, reiterated last year's slogan for teachers and said this year's is "listen up and speak up". She noted that so far administrators had listened to their concerns by starting off the school year with a hybrid.

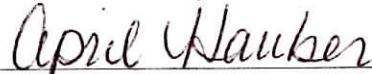

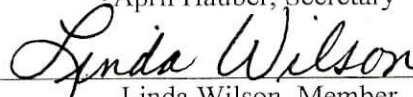
