Call to Order/Pledge of Allegiance

Mr. Hansford called the Regular Meeting to order at 7:00 p.m. and asked those in attendance to recite the Pledge of Allegiance.

Amend and/or Adopt Agenda

Ms. Wilson made a motion to adopt the agenda, as presented. Ms. Cummings seconded; the vote was unanimous.

Reports of School and Organization Representatives

Superintendent's Reports: Superintendent Bennett told the Board that the required pre-bargaining public hearing for the collective bargaining law was held prior to the Board meeting. She says formal bargaining begins September 15, 2020. She said there are still many uncertainties around school funding and noted the first ADM count date may be moved from September 18 to as late as December or early January.

Superintendent Bennett said CCSC would be reopening at full capacity on Monday, August 24. She said the COVID case count and positivity rate is stable and not rising in Clark and Floyd counties. She said the plan has been approved by the Clark County Health Department. She said CCSC will continue to require mask wearing, social distancing, and following seating charts to help with contact tracing.

Superintendent Bennett updated the Board on enrollment, saying there are 1226 students currently attending the brick and mortar. She said count day last September was 1346 but noted about 100

Clarksville students were attending Indiana Gateway Digital Academy. She noted that the ADM number is better than what neighboring districts are seeing. Dr. Brian Allred, Assistant Superintendent, reported that statewide 1253 students are attending Indiana Gateway Digital Academy and said all administrators have been hired.

Superintendent Bennett said the CHS Football team hosts Scottsburg on Friday night at 7 p.m. She said the safety plan was approved by the Clark County Health Department. She noted there is a 250 person max per bleacher and said there will be areas gated off to prevent comingling. She also said there will be additional port a pots and handwashing stations for the visitor's side. She said there will be new entrances and additional signage to help direct the crowd. She noted that CMS sports would begin next Monday and CES sports would start later in September.

Comments

C. E. A. Communications: Ms. Sally Wade, C.E.A. Secretary, reminded the Board that this year's slogan is "listen up and speak up". She said that members are listening and working hard for students. She also said they are speaking up when they have concerns.

Comments from Board Members: Ms. Wilson thanked cafeteria workers for all their work for providing meals to students during remote learning. She said they work hard and deserve the extra recognition. Mr. Wilson said he understands the workload teachers are facing this year and said he empathizes for what they will have to go through.

Upon Superintendent Bennett's recommendation, Ms. Hauber made a motion to approve the Consent Agenda, as presented. Ms. Wilson seconded; the vote was unanimous.

Revision to Athletic Handbook for 2020/2021

Ms. Wilson seconded; the vote was unanimous. The revision includes a liability waiver for parents and/or legal guardians to sign in order to transport student athletes to and from athletic events.

Other



Board Members signed various documents.




