**Fund Raising Request**

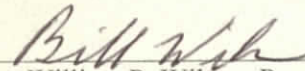

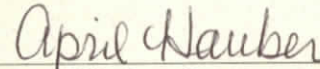
**Adjourn**

With no further business to discuss, Mr. Wilson adjourned the Special Meeting at 7:10 p.m. and called the Planning Session to order.

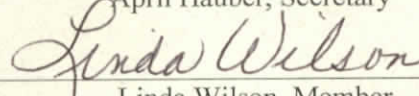

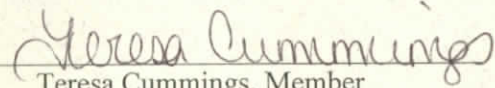
