**Education Update**

Superintendent Bennett said there will be ongoing conversations with Dr. Yazel and the Health Department over winter break to determine the learning model for January. Currently students are scheduled to return to in person learning on January 4. Superintendent Bennett said small groups of students who need additional academic support are being brought to school to help with learning gaps. Superintendent Bennett said high school basketball is underway and games are being live streamed for the general public. She noted that middle school basketball has resumed practice and there are no elementary school sports right now. Superintendent Bennett noted that band and choir students are being brought in for practice and to record a virtual winter concert. Superintendent Bennett said the graduation date is set for May 28, 2021.

Dr. Brian Allred, Assistant Superintendent, reported that Indiana Gateway Digital Academy is offering several virtual professional development opportunities to CCSC teachers.

Superintendent Bennett introduced Ms. Erin Walden, Communications Specialist. Ms. Walden discussed a new campaign that was getting ready to launch called "I Believe". She said students, staff and parents were interviewed with testimonials about why they believe in CCSC. She said there would be commercials, videos and mailers. Ms. Walden also said surveys were being sent to parents of both brick and mortar and INGDA to try and determine what second semester would look like.
