Call to Order

Mr. Wilson called the Planning Session to order at 7:00 p.m.

Amend and/or Adopt Agenda

Ms. Wilson made a motion to adopt the agenda, as presented. Mr. Hansford seconded; the vote was unanimous.

Student of the Month Recognitions

Superintendent Bennett reminded the Board that CCSC was catching up on honoring Students of the Month due to COVID-19. Erika Rasche from Clarksville Middle School, Sydnee Davis from Clarksville Elementary School and Mayson Stocksdales from Clarksville High School were all in attendance. Alex Robinson from Renaissance Academy was unable to attend.

Education Update

Superintendent Bennett updated the Board on several initiatives involving CCSC teachers. Stephanie Anderson, ESL Director and CES teacher, is scheduled to take part in an Indiana Department of Education social media event called #loveteaching week. Nikki Mullins, CES teacher, is planning on being part of a panel for Leadership Southern Indiana discussing the challenges and successes of teaching during a pandemic. She also reported that several teachers are participating in the utilization of Swivl

devices beginning in the 2021-2022 school year. These teachers will be the point persons for the train the trainer model. Swivl devices are mini cameras that teachers will wear to record their lessons. The recordings will be used for self-reflection and evaluations as well as the ability to be used for virtual building tours to be sent to potential students who want to enroll in Clarksville Community Schools. Superintendent Bennett said discussions are underway with the Clarksville Historical Society on how to commemorate Eleanor Roosevelt's visit to Clarksville High School in 1958. She also noted that funding is anticipated from the Cares 2 Act to address learning gaps due to COVID-19.

Dr. Brian Allred, Assistant Superintendent, reported that Indiana Gateway Digital Academy will reach the threshold for testing this year, which is good for a first time school. He reported that ISTEP is completed for CCSC students and IREAD-3 was next. Dr. Allred noted that he has been overlooking Special Education to make sure IEP goals were being met due to remote learning. He also said the High Ability program was moving forward.

Superintendent's Reports

Superintendent Bennett updated the Board on COVID-19, noting that the numbers are low since returning from winter break. She reported that the audit was complete. She said CCSC had four findings that were process related and had already been addressed. She noted the total cost was \$45,000, a dramatic increase from past audits. Superintendent Bennett said the design development drawings had been reviewed with the architect for the middle school multipurpose area and administration building projects. She said all costs were within the projected budget.

Comments

C. E. A. Communications: Ms. Christina Schotter, C.E.A. President, thanked the Board for their consideration of the resolution opposing ESA and voucher expansion. She said she appreciated the Board standing with teachers in this matter.

Comments from Board Members: Mr. Hansford said he was glad the middle school baseball and softball clubs would now be sponsored by the school.

Update to NEOLA Board Policy

Superintendent Bennett discussed a revision to NEOLA Board Policy #6250. She noted that the policy update is needed to match current practice in regards to the ADM count.




With no further business to discuss, Mr. Wilson adjourned the Planning Session at 7:45 p.m.






