Call to Order

Mr. Wilson called the Planning Session to order at 7:05 p.m.

Amend and/or Adopt Agenda

Mr. Hansford made a motion to adopt the agenda, as presented. Ms. Hauber seconded; the vote was manimous.

Superintendent Bennett honored the Students of the Month. Brooklyn Minton from Clarksville Elementary School, Alejandro Elizondo from Clarksville Middle School, Caden Owens from Renaissance Academy and Mark Berkey from Renaissance Academy were all in attendance. Kelsey Pease from Clarksville High School was unable to attend.

Superintendent Bennett introduced Stacey White, Coordinator of the JAG program. Ms. White discussed the success CCSC had this year in the program and honored various students.

Education Update

Superintendent Bennett said Generals Success Camp started at each of the buildings with over 300 students and over 30 staff members involved. She said camp would run Monday-Thursday through the end of June. She said students are also receiving breakfast and lunch each day.

Superintendent Bennett said the ESSER-2 grant was approved and the portal has opened for the ESSER-3 grant. She noted one of the initiatives is to hold professional development for all staff members that would result in a \$1000 stipend.

Dr. Brian Allred, Assistant Superintendent, said testing is complete for the school year but noted the data isn't yet available.

Superintendent Bennett thanked all the Board members for their attendance at graduation and for all staff members who helped make it a beautiful ceremony.

Superintendent's Reports

Superintendent Bennett said she would have a COVID-19 summary the following week. She noted that June 14 is the anticipated start date for the renovation of the new Administration Center with weekly construction meetings starting at the end of June. She also said a timeline is being worked on for updates to the current administration building. Superintendent Bennett said First Savings Bank would once again be a Platinum sponsor for the 2021-2022 school year. She also said Coyle Chevrolet would be a second platinum sponsor and would be recognized at an upcoming Board meeting.

Comments

There were no C.E.A. comments.

Comments from Residents: Ms. Shirley Stevens signed up to speak. She said it was irresponsible that CCSC didn't have a teacher in two of her daughter's classes. She also expressed anger about seven students who were not allowed to walk at graduation. She said she felt that it was the wrong decision.

Comments from Board Members: Ms. Cummings said while she acknowledged that the seven students misbehaved and caused disruption she was torn on the punishment when it came to the graduation walk. She said at no time has she questioned that the administration wasn't doing what they feel is best for the students. She also said CES version of "We Are the World" was probably the best video she has seen in recent days. Ms. Wilson said it bothered her that the graduation controversy was reduced to hate. She said she and the others sit on the Board because they care about the school system and the kids. Ms. Hauber thanked everyone for a successful school year. Mr. Hansford said he felt everyone was united for this school year.

Kelly Services Agreement

Superintendent Bennett discussed increasing the daily sub rate with Kelly Services from \$70 to \$75 a day and decreasing requirements from college credit to a high school diploma. She said this would put CCSC more in line with other area schools in hopes of increasing the sub pool.

Eventlink Agreement

Superintendent Bennett discussed a recommendation from the Athletic Director to switch from Go Fan to Eventlink for online ticketing for the 2021-2022 school year. She noted there would be no additional fee as CCSC already subscribes to Eventlink.

Communities in Schools Agreement

Superintendent Bennett discussed the Agreement with Communities in Schools of Clark County for the 2021-2022 school year. She noted there were no changes to the cost or terms from the 2020-2021 school year.

Wrestling Recommendation

Superintendent Bennett discussed a recommendation from the Athletic Director to add wrestling as an ISHAA school sponsored sport at CHS beginning in the 2021-2022 school year. She noted that this would increase the number of winter sport opportunities for student athletes.

Uniform Conflict of Interest Disclosure Statements

Superintendent Bennett discussed several Conflict of Interest Disclosure Statements for board members and staff members that are completed on an annual basis. She said that once approved they would be filed with the County Clerk's Office and State Board of Accounts.
