Call to Order/Pledge of Allegiance

Mr. Wilson called the Regular Meeting to order at 7:00 p.m. and asked those in attendance to recite the Pledge of Allegiance.

Amend and/or Adopt Agenda

Ms. Wilson made a motion to adopt the agenda, as presented. Ms. Cummings seconded; the vote was unanimous.

Acknowledgements and Recognitions

Superintendent Bennett honored Mr. Chris Coyle, owner of Coyle Chevrolet, as a Platinum sponsor for Clarksville Community Schools. She said that he donated \$5000 and thanked him for his support.

Reports of School and Organization Representatives

Superintendent's Reports: Superintendent Bennett reported that enrollment is currently at 1356 but noted that the numbers continue to fluctuate. Superintendent Bennett said there have been some COVID cases but they have led to minimal disruption this school year. Superintendent Bennett reported that she and the C.E.A. had met earlier and held the pre-bargaining public hearing that's required by law. She said formal bargaining begins September 15.

Superintendent Bennett reported that 18-20 more students were riding the bus from the Parkwood area. She noted these students were not previously attending Clarksville. Superintendent Bennett said fall sports is underway with football opening Friday at Scottsburg. She said the number of participants in girls and boys sports is up. Superintendent Bennett updated the Board on the pancreatic cancer diagnosis for Clarksville High School Teacher, Mr. Dan Bullington, and asked them to keep him and his family in their thoughts and prayers.

Dr. Brian Allred, Assistant Superintendent, said enrollment at Indiana Gateway Digital Academy was currently at 1591 with hundreds more in the pipeline.

Superintendent Bennett introduced Ms. Bronte Murrell from the Town of Clarksville. Ms. Murrell talked about the Beat the Heat Program. Ms. Murrell said the program is designed to help combat the public health impacts of extreme summer heat in Clarksville. Mr. David Gardner, Science Teacher at Clarksville High School and Renaissance Academy, said dozens of students are interested in volunteering their time to help map the heat.

Comments

C. E. A. Communications: Ms. Sally Wade, C.E.A. Vice President, said many classes are seeing a rise in student count this year. She said teachers are juggling class sizes and caseloads. She said the C.E.A. continues to support teachers as they move into new roles. She said she expected teachers to get benefits from the increased enrollment.

Comments from Board Members: Ms. Wilson reminded everyone to come out to the football game on Friday.

Board members signed various documents.



With no further business to discuss, Mr. Wilson adjourned the Regular Meeting at 7:34 p.m.




