Education Update and Superintendent's Reports

Superintendent Bennett reported current enrollment has averaged around 1360 students this school year. She noted that count day is coming up. She updated the Board on the newest guidance from the Indiana Department of Health. The changes involve who needs to quarantine if identified as a close contact. She said lunch and extra-curricular activities are still the biggest challenges for mitigation efforts. She said CCSC will continue these efforts in order to keep students in-person. Superintendent Bennett said the ECA audits were complete at CES, CMS and CHS. She said there were no incidences of non-compliance. She said RA's audit could take longer as the account was closed during the audit period. Superintendent Bennett said she was honored to attend the Presidential Awards for Excellence in Mathematics and Science Teaching Luncheon with Ms. Jaime Lamkin. Ms. Lamkin was recognized as one of the top three math teachers in the state and is now in the running as a national finalist. Superintendent Bennett reminded the Board that the next meeting begins student of the month recognitions for the 2021-2022 school year. She also said the first home football game is Friday Providence.
