### Adoption of 2022 Budget and Approval of Resolutions

Upon Superintendent Bennett's recommendation, Ms. Cummings made a motion to adopt the 2022 Budget and approve the CPF and Bus Replacement Plans and Resolutions, as presented at the budget hearing on October 5<sup>th</sup>. Ms. Davis Craig seconded; the vote was unanimous.

### Education Update and Superintendent's Reports

Superintendent Bennett updated the Board on the new School Accountability system. Instead of the letter grade metric, the system looks at five characteristics which best indicate a student's preparation for success after high school. She said the DOE is now soliciting public comment on the Indiana Graduates Prepared to Succeed (GPS) dashboard. Superintendent Bennett said the head of strategic partnerships for the Modern Classrooms Project is scheduled to visit with teachers in November. She said CCSC is one of two schools in the state to roll out the new program. Superintendent Bennett noted there are currently 20 tables scheduled for the Trick or Treat night at Clarksville Middle School. She reminded the Board that Clarksville will be hosting the first game of the football sectionals on Friday, taking on Mitchell.

Dr. Brian Allred, Assistant Superintendent, introduced the new Head of Schools for Indiana Gateway Digital Academy. Mr. Dwight Ashley said he is happy to be here. Dr. Allred said current enrollment for INGDA is 1973. He also said the testing security training will be held the next day and updated the Board on the use of grant funds for SWIVL and Cambium Training.

Ms. Carey Davis, Clarksville Elementary School Principal and Mr. Andrew Smith, Clarksville Elementary School Assistant Principal, said current enrollment at CES is 570, up 80 from last year. They noted that a 5<sup>th</sup> Kindergarten Teacher and 5<sup>th</sup> 1<sup>st</sup> Grade Teacher were added as a result of the increased enrollment. Mr. Smith discussed various before and after school programming options. Ms. Davis said intervention groups are up and running. Mr. Smith said the annual Walk-A-Thon was a success, thanked community partners and talked about upcoming programs. Ms. Davis said it was great to see the CES students honored at the Clark Fest parade.

Ms. Erin Walden, Communications Specialist, said she is still filling in the gaps during the transition to a new Communications Coordinator. She noted Ms. Becca Gibson is working two hours a week with her for training. Ms. Walden noted the community response to CCSC at Clark Fest was outstanding.

### Comments

C. E. A. Communications: Ms. Christina Schotter, C.E.A. President, congratulated the students of the month. She thanked the Board for working with teachers around parent/teacher conferences. Ms. Schotter thanked Erin Walden for her work and partnership.

Comments from Citizens: Two citizens signed up to speak. Ms. Peighton Radlein said she was a 2014 graduate and described how much of an impact Mr. Dan Bullington, Theater Director, had on her life while she attended Clarksville. She hoped the Board would consider naming the theater after him. Ms. Jessica Braddock said Mr. Bullington had a talent for immersing his students in the culture. She offered a petition with over 1000 signatures to rename the theater and said doing it now gives him a chance to see the impact he's had.

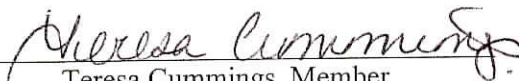

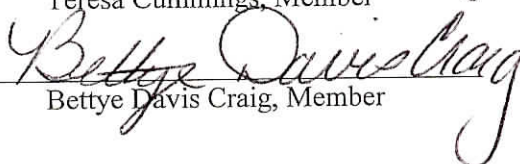
