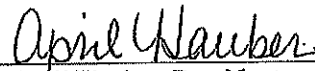

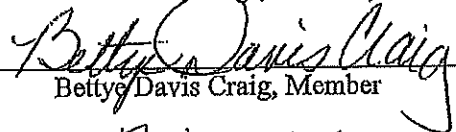

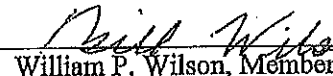

**2023 Budget Hearing**

Ms. Hauber opened the 2023 Budget Hearing.

Dr. Bennett discussed the 2023 Budget. She said the AV is \$454,411,807 (expected to be \$526,194,328). She said the estimate was low to keep tax rates at a level to protect levies. She also noted the total circuit breaker impact as estimated by the DLGF is \$1,686,840. She said the certified ADM was 1354 for brick and mortar and 2468 for Indiana Gateway Digital Academy. She noted she would bring recommendations back in two weeks to approve the budget as well as approve various resolutions.

Ms. Hauber opened the floor for taxpayer questions and comments. Mr. Wilson had a question about increase on last year's virtual count, Dr. Bennett answered. Christina Schotter asked bill about the Tiff wording and when they may change it, he answered and commented he will let us all know once he finds out. Ms. Hauber closed the 2023 Budget Hearing.

**Education Update and Superintendent's Reports**

Dr. Bennett discussed the current enrollment and upcoming important dates, the administration parking lot entrance being paved. Dr. Bennett also informed the Board when the Title 3 family night was and how great that is. She mentioned that CES Digital Marquee is up and looks wonderful.

Dr. Bennett discussed Orton Gillingham Training and how increasing stem innovating in K-8 is trying to be more intentional. She discussed that Dr. Allred met with a company representative who will be coming onsite on 10/17 to look at CES and CMS and give us some advice on making a full stem lab, have teachers fully trained on this innovative as early as next fall. Our goal is to become fully certified. This is a great opportunity for our students. Through Marion University, we currently have 9 teachers trained, 2 trained in math and 2 teachers plus 1 assistant that also started tutoring.

**Education Update and Dr.'s Reports:**

Dr. Bennett started off thanking those that represented CCSC at Clarkfest, this event was covered by CMS and CES staff. "Our booth had many visitors and it was nice to engage with the community. We are already brainstorming ways to make our booth bigger and better next year."

Dr. Bennett went on to talk about our annual Trick or Treat Event being held at Clarksville Middle School on Thursday, Oct 27 from 6-8. "We currently have 25+ tables requested. We will be doing another social media push to get any last-minute tables reserved leading up to the event. At this time last year, we had approximately 20 tables reserved."

Dr. Bennett gave an updated on the Administration parking lot. She mentioned that over fall break the administration parking lot entrance was completed. She thanked our facilities team for ensuring that this project was completed in a timely fashion.
