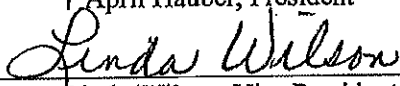

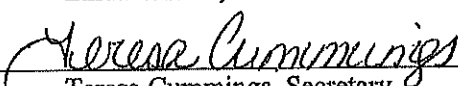

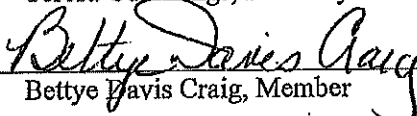

Donations:

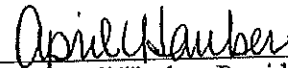
Dr. Bennett discussed donations.

Adjourn:

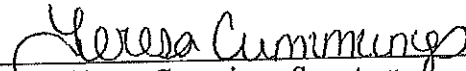

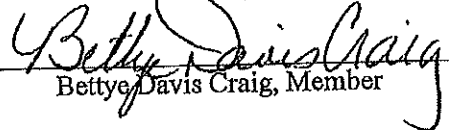
